Election (2024-25) to the Managing Committee of Eastern India Chartered Accountants Students' Association (EICASA) of EIRC of ICAI

This is to announce that the Election (2024-2025) to the Managing Committee of the Eastern India Chartered Accountants Students' Association (EICASA) will be held on Saturday, 16<sup>th</sup> March 2024 from 4:00 pm at ICAI Bhawan, Russell Street Premises.

The Eastern India Chartered Accountants' Students' Association (EICASA) Managing Committee 2024-25 shall be comprised of 12 Members elected by the Members of the Eastern India Chartered Accountants Students' Association (EICASA) from amongst the Members of the Eastern India Chartered Accountants Students' Association (EICASA). Relevant rules regarding eligibility to vote, eligibility to contest for election, mode of filing Nomination etc. are given below:

- a. Every student who is a member of the Eastern India Chartered Accountants Students' Association on the 1st day of March, 2024, i.e. undergoing Articleship training under any CA at Eastern Region shall be entitled to vote provided he or she continues to be a member on the date of election (i.e. 16th March 2024).
- b. Every student who fulfills the above requirement shall be eligible to contest for election to the Managing Committee of the Eastern India Chartered Accountants' Students' Association provided the unexpired training period of at-least one year as on 1<sup>st</sup> Day of March.
- c. The following are the methods for submitting a nomination form for election candidacy:
  - (i) The form can be mailed or hand-delivered to the EICASA Secretariat, located on the 3rd floor of the ICAI Bhawan, 7 Russell Street. Submissions are accepted from 11 am to 5 pm, Monday through Friday.
  - (ii) The form can be sent electronically from the candidate's registered email address as a scanned, signed copy. It should be emailed to <a href="mailto:eicasachairman@icai.in">eicasachairman@icai.in</a> with a carbon copy to <a href="mailto:eicasacevents@icai.in">eicasacevents@icai.in</a>.

The nomination form should be addressed to the Chairman of the Eastern India Chartered Accountants' Students' Association Managing Committee. It must be signed by the candidate and endorsed by a Proposer and a Seconder, both of whom must be eligible to vote in the election. The form must be received no later than 5 pm on March 11, 2024.

- d. Nomination forms will be available from the EICASA Secretariat at 3rd floor of ICAI Bhawan, Russell Street on any working day during 11.00 am to 5.00 pm from 24th February 2024 till 5.00pm on 11th March, 2024. Every candidate for election shall pay an amount of Rs. 10/- which shall not be refunded under any circumstances.
- e. Last date for withdrawal of nomination would be 12th March 2024 upto 5.00 pm. (mail informing withdrawal of nomination should be given to all the above e-mail Ids where the nomination form has been mailed from registered e-mail id of the contesting candidate. Additionally, hardcopy of the same should be sent by post or by hand to EIRC office).
- f. Final List of Candidate will be hoisted on EIRC website on 14th March 2024.
- g. The election shall be conducted by poll and casting of votes present at the meeting. No Proxy shall be allowed.
- h. The Chairman of the meeting shall announce the names of all candidates elected after the election or on the subsequent working day and his declaration shall be final.
