## The Brief Details of the Terms and Conditions for the engagement as Young Professional are as follows:

- 1. The Young Professional would be appointed to undertake mainly the work relating to legal/court cases including Inspection, Investigation and Inquiry under the Companies Act, 2013 and all other technical and related matters of field offices as well as any other work as per the emerging requirements of the Ministry.
- 2. The initial engagement as Young Professional may be for a minimum period of 03 (three) months and thereafter, the engagement would be reviewed and it would not exceed one year at a time and subject to the condition that the total engagement should not exceed the maximum term i.e. four years.
- 3. The appointment of Young Professional would be on full-time basis and they would not be permitted to take up any other assignment during the period of appointment as Young Professional with the Ministry of Corporate Affairs.
- 4. The appointment of Young Professional is of a temporary nature against the specific jobs/assignments. The appointment can be cancelled at any time by the Ministry without assigning any reasons.
- 5. Experience ( Employment / Practice/Research) in the relevant discipline - 3 to 5 years.
