Election (2023-2024) to the Managing Committee of Eastern India Chartered Accountants Students' Association (EICASA) of EIRC of ICAI

This is to announce that the Election (2023-2024) to the Managing Committee of the Eastern India Chartered Accountants Students' Association (EICASA) will be held on **Saturday, 29th July 2023** during Annual General Meeting of EICASA for the year 2022-23 from 6.30 PM at ICAI Bhawan, Russell Street Premises.

The Eastern India Chartered Accountants' Students' Association (EICASA) Managing Committee -2023-24 shall be comprised of 12 Members elected by the Members of the Eastern India Chartered Accountants Students' Association (EICASA) from amongst the Members of the Eastern India Chartered Accountants Students' Association (EICASA). Relevant rules regarding eligibility to vote, eligibility to contest for election, mode of filing Nomination etc. are given below:

- a. Every student who is a member of the Eastern India Chartered Accountants Students' Association on the 1st day of April, 2023, i.e. undergoing Articleship training under any CA at Eastern Region shall be entitled to vote provided he or she continues to be a member on the date of election (i.e. 29th July 2023).
- b. Every student who fulfills the above requirement shall be eligible to contest for election to the Managing Committee of the Eastern India Chartered Accountants' Students' Association provided that his or her un-expired period of training is not less than 12 months on 16.09.2023.
- C. Any person who desires to contest for election shall submit the nomination form (scanned copy of the duly signed nomination form to be sent from the registered e-mail-id of the contesting candidate to (eicasachairman@icai.in with a cc to sanjib@ssanghico.com) to the Chairman of the Eastern India Chartered Accountants' Students' Association Managing Committee duly signed by the candidate and by the Proposer and Seconder, both of whom shall be persons entitled to vote in the election, so as to reach latest by 5 PM on 19th July 2023.
- d. Nomination forms will be available from the Regional Council Section on any working day during 11.00 AM to 4.00 PM from 10th July 2023 till 4.45pm on 19th July 2023. Every candidate for election shall pay an amount of Rs. 10/- which shall not be refunded under any circumstances.
- e. Last date for withdrawal of nomination would be 21st July 2023 upto 5.00 PM. (mail informing withdrawal of nomination should be given to all the above e-mail Ids where the nomination form has been mailed from registered e-mail id of the contesting candidate. Additionally, hardcopy of the same should be sent by post or by hand to EIRC office).
- Final List of Candidate will be hoisted on EIRC website on 27th July 2023.
- g. The election shall be conducted by poll of members and casting of votes present at the meeting. No Proxy shall be allowed.
- h. The Chairman of the meeting shall announce the names of all candidates elected after the election or on the subsequent working day and his declaration shall be final.
