**Election (2026-27) to the Managing Committee of Eastern India Chartered Accountants Students' Association (EICASA) of EIRC of ICAI**

This is to announce that the Election (2026-2027) to the Managing Committee of the Eastern India Chartered Accountants Students' Association (EICASA) will be held on **Friday, 6<sup>th</sup> March 2026** from **2:00 P.M to 8:00 PM** at ICAI Bhawan, Russell Street Premises.

The Eastern India Chartered Accountants' Students' Association (EICASA) Managing Committee 2026-27 shall be comprised of 12 Members elected by the Members of the Eastern India Chartered Accountants Students' Association (EICASA) from amongst the Members of the Eastern India Chartered Accountants Students' Association (EICASA). Relevant rules regarding eligibility to vote, eligibility to contest for election, mode of filing Nomination etc. are given below:

- a. Every student who is a member of the Eastern India Chartered Accountants Students' Association on the **1<sup>st</sup> day of March, 2026**, i.e. undergoing Articleship training under any CA at Eastern Region shall be entitled to vote provided he or she continues to be a member on the date of election (i.e.**6<sup>th</sup> March 2026**).
- b. Every student who fulfills the above requirement shall be eligible to contest for election to the Managing Committee of the Eastern India Chartered Accountants' Students' Association provided the unexpired training period of at-least one year as on **1<sup>st</sup> Day of March 2027**.
- c. Any person who desires to contest for election shall submit the nomination form can be filed either by the following means:  
**(i)** to be sent by post or by hand to EICASA Secretariat at **3<sup>rd</sup> floor of ICAI Bhawan, 7, Russell Street from 11am to 6pm between Monday to Friday** or  
**(ii)** to be sent from the registered e-mail-id of the candidate (scanned copy of the duly signed nomination form) of the contesting candidate to [eicasachairman@icai.in](mailto:eicasachairman@icai.in) with a cc to [eicasaevents@icai.in](mailto:eicasaevents@icai.in).

Addressed to the Chairman of the Eastern India Chartered Accountants' Students' Association Managing Committee duly signed by the candidate and by the Proposer and Seconder, both of whom shall be persons entitled to vote in the election, so as to reach latest by 6 pm on **2<sup>nd</sup> March, 2026**.

- d. Nomination forms will be available from the EICASA Secretariat at 3<sup>rd</sup> floor of ICAI Bhawan, Russell Street on any working day during 11.00 AM to 6.00 PM from **20<sup>th</sup> February 2026** till 5.00 pm on **2<sup>nd</sup> March, 2026**. Every candidate for election shall pay an amount of **Rs.10/-** which shall not be refunded under any circumstances.
- e. Last date for withdrawal of nomination would be **3<sup>rd</sup> March 2026** upto **6:00 PM** (mail informing withdrawal of nomination should be given to all the above e-mail Ids where the nomination form has been mailed from registered e-mail id of the contesting candidate. Additionally, hardcopy of the same should be sent by post or by hand to EIRC office).
- f. Final List of Candidate will be hosted on EIRC website on **4<sup>th</sup> March 2026 after 5.00 P.M.**
- g. The election shall be conducted by poll and casting of votes present at the meeting. No Proxy shall be allowed.
- h. The Chairman of the meeting shall announce the names of all candidates elected after the election or on the subsequent working day and his declaration shall be final.
