With reference to the subject cited, I am directed to state that the Ministry vide letter no. A-42/47/2020-Ad.II-MCA-Part(2) dated 05.06.2024 has issued revised guidelines and procedure for engagement of Young Professionals in the Ministry of Corporate Affairs.

2. **In terms of the said revised guidelines, the monthly consolidated remuneration of YP has been increased from Rs.41,000/- to Rs.50,000/- (Fifty thousand) for First year besides annual increment of Rs.5,000/-(Five thousand) and therefore, monthly consolidated remuneration of YP in the 4th and Final year will be Rs.65,000/- (Sixty five thousand).**

The experience criteria of YP post passing final examination has also been reduced from two (02) years to (01) year.

3. In terms of the said revised guidelines and procedure, this Directorate is in the process to engage Young Professionals (YP) for the office of Regional Director (ER), Kolkata, ROC, Kolkata -I and ROC, Kolkata -II.
