- 1. Debate will be 'For'/'Against' motion related to topic chosen from amongst the topics given by SSEB (Board of Studies- Operations).
- 2. The medium of Debate Competition would be held in English language only.
- 3. Competition would not be held for a particular topic if an even number of students did not register **For** & **Against** a particular topic.
- 4. Total Time allotment to each pair shall be 10 minutes
  - a. 3 Minutes + 3 minutes (Presentation For & Against on each topic)
  - b. 2 Minutes + 2 Minutes (Rebuttal Round/Counter-argument) by pair of each topic.
- 5. During Rebuttal Round, the judges' decision to allow/disallow the speaker to speak will be final.
- 6. One Participant from **For** and one participant from **Against** side will be chosen as winners from Final Round.
- 7. The Top Two Winners (**One 'For'** and **One 'Against' the motion**) at Branch Level will be contesting at Regional Level.

7.	Adherence to time limit	10 Marks
