
initiative to compile the experiences and thoughts of our senior members - an initiative to showcase that Age is not just a Number, but a metric to invaluable experiences.





Chartered Accountants' Benevolent Fund (CABF)

OVERVIEW & OBJECTIVE:

The Chartered Accountants' Benevolent Fund (CABF) was established in December, 1962 to provide financial assistance to members or their families in distress.

The objective for which the fund is established is to provide financial assistance for maintenance, education or any other similar purpose to necessitous persons being:-

- (a) persons who are or have been members of the Institute, whether subscribers to the fund or not; or
- (b) wives and children of persons who are or have been members of the Institute, whether subscribers to the fund or not.
- (c) widows and children of deceased persons who have been members of the Institute whether subscribers to the fund or not.
- (d) relatives or others who were dependent for support on a person who has been a member of the Institute, whether subscriber to the fund or not; and who has died without leaving a widow or child.

WHO ALL ARE ELIGIBLE FOR CABF ASSISTANCE:

- a) Members of the Institute, whether subscribers to the fund or not.
- b) Spouses/widows and children of members, whether subscribers to the fund or not.
- c) Relatives or others who were dependent for support on a member, whether subscriber to the fund or not; and who has died without leaving a widow or child.

TYPES OF MEMBERSHIP:

Life Member: A single payment of Rs. 10,000/- shall make a person eligible to be admitted as a life member of the fund w.e.f. 1st January, 2020. Thereafter he shall not be liable to pay any amount on account of subscription and shall be designed as a 'Life Member'.

<u>Annual Member</u>: All other members shall be described as 'Annual Members' and shall have to pay an annual subscription of Rs. 1,000/-.

Voluntary Contribution: Any ICAI Member can give 'Voluntary Contribution' to CABF of any desired amount

Procedure for availing financial assistance



Application should be made in prescribed format along with all relevant supporting documents. The application must be recommended by a Central Council Member or Office Bearer of Regional Council or Office Bearers of Branches or Ex-President/Chairman/Vice-Chairman and Member Secretary/Member of Managing Committee of CABF. Formats of the application can be downloaded from https://www.icai.org/post/ca-benevolent-award

Types of Financial Assistance

Monthly

Maximum monthly assistance available to a member or persons eligible to receive the assistance is from **Rs.15,000/- to Rs.25,000/- per month** according to the circumstances of the use renewable after one year. This is for maintenance of family of members/widow/relatives of deceased members.

Financial assistance will be given only to the members/widows/relatives whose monthly family income is not more than Rs. 25,000/- per month.

Ex-gratia

Maximum financial assistance of **Rs.150000/-** is provided to the legal heir of deceased member in case of accidental death/ unnatural death at the age below 55 years against claim.

Medical

Maximum financial assistance of **Rs.1,50,000/-** available to a member or dependent of member eligible to receive the assistance.

Financial assistance will be given only to the members/widows/relatives whose monthly family income is not more than Rs. 25,000/- per month.





No automatic reversal of Input Tax Credit from the buyer upon non-payment of tax by the supplier:

<u>lssue:</u>

As per section 16(2)(c) of the CGST Act, one of the conditions to claim GST Input Tax Credit is that the output tax collected by the supplier from the buyer in respect of the supply has actually been paid to the Government.

The buyer is being made to reverse GST Input Tax Credit due to non-payment of tax by the supplier to the government by the issue of notices in respect of financial years 2017-18 to 2021-22.

Solution:

The buyer may challenge such reversal of GST Input Tax Credit on the following grounds:

- The buyer has a valid tax invoice and payment to the supplier has been substantiated by producing the bank statement. Before directing the buyer to reverse the GST input tax credit, the GST Department ought to have acted towards the recovery of tax from the defaulting seller. Straight away the GST Department was not justified in directing the buyer to reverse the GST input tax credit availed by them until and unless it is an exceptional case where there has been collusion between the buyer and the seller or where the seller is missing or the seller has closed down its business or the seller does not have any assets. Reliance is placed on the *Honourable Supreme Court of India upholding the Honourable Calcutta High Court Judgment in the case of Suncraft Energy Private Limited (2023).* Further, reliance is placed on the Honourable Madras High Court judgment in the case of D.Y. Beathel Enterprises (2021).
- Reliance may be placed on the Doctrine of impossibility which mentions that law cannot compel a man to do anything which is impossible. The buyer cannot be expected to keep a track of whether the selling dealer has indeed deposited the tax so collected since such buyer cannot exercise any control over his supplier's actions. Reliance is placed on the Honourable Supreme Court judgment of Kay Kay Industries (2013) and of Bombay High Court judgment in the case of INDIAN SEAMLESS STEEL AND ALLOYS LTD (2002).
- Treatment of both the parties, the guilty seller and the innocent purchaser at par is a violation of Article 14 of the Constitution. Further, penalizing the buyer for the fault of the defaulting supplier, even in the absence of any collusion between the two is unjust. Where the purchaser is bonafide and there is absence of mala fide intention, connivance or collusion of the purchaser with the supplier to defraud the GST Department, the reversal of Input Tax Credit cannot be sought from purchaser. Reliance is placed on the Honourable Delhi High Court judgment in the case of Arise India Limited (2017).







- The law has to acknowledge the necessity to differentiate between honest and dishonest taxpayers. Law cannot anticipate a possibility of a virtually impossible eventuality and the liability can only be fastened to a person who either acts fraudulently or has been a party in collusion with the offender. Law ought not to put an onerous responsibility on the innocent buyer otherwise, law may violate the Articles 14 and 19 of the Constitution of India. Reliance is placed on the Honourable Punjab and Haryana High Court judgment in the case of Gheru Lal Bal Chand (2011).
- Several writ petitions have been filed challenging the constitutional validity of section 16(2)(c) of the CGST Act, challenging it to be ultra-virus and violative to Article 14 of the Constitution of India. Reliance is placed on the *Honourable Calcutta High Court judgment in the case LGW INDUSTRIES Limited (2021)*.
- Reliance may be placed on page 1 of the Press Release dated 4.05.2018 issued by the Central Board of GST Council which states that there shall not be any automatic reversal of input tax credit from buyer on non-payment of tax by the seller. Only in exceptional situations can the buyer be asked to reverse the input tax credit.

Therefore, before directing the appellant to reverse the input tax credit and remit the same to the government, the first respondent ought to have taken action against the fourth respondent the selling dealer and unless and until the first respondent is able to bring out the exceptional case where there has been collusion between the appellant and the fourth respondent or where the fourth respondent is missing or the fourth respondent does not have any assets and such other contingencies, straight away the first respondent was not justified in directing the appellant to reverse the input tax credit availed by them - the demand raised on the appellant is not sustainable.
2	Hon'ble Madras High Court in the case of M/S. D.Y. BEATHEL ENTERPRISES VERSUS THE STATE TAX OFFICER (DATA CELL), (INVESTIGATIONWING) COMMERCIAL TAX BUILDINGS, TIRUNELVELI, (2021)	The Department could not demand GST from the recipient without first examining the supplier and initiating recovery action against the supplier.
