

COOPERATIVE SECTOR AND TAX INCENTIVES

INTRODUCTION:

A tax incentive is a component of a government's taxation strategy intended to support an economic activity by lowering tax obligations. It has positive and negative effect on an economy. If the tax incentive is designed with proper planning and implement in an absolute way, it can attract investment to a country. There are some other benefits which includes increased employment, higher number of capital transfers, research and technology development, improvement to underdeveloped areas, etc.

UNION BUDGET 2023-24:

The Union Budget for Financial Year 2023-24 outlines the following as the core principles of the "Amrit Kaal" vision:

- Citizen opportunities with an emphasis on youth
- Development and job creation
- A robust and stable macroeconomic climate

The Union Budget has following 7 priorities, collectively known as Saptarishi, as a roadmap for an empowerment to lead the nation toward "Amrit Kaal":

- Inclusive Development
- Reaching the last mile
- Infrastructure and Investment
- ②Unleashing the potential
- @Green Growth
- ②Youth Power

This year's Union Budget seeks to improve India's economic standing even more. With its economic growth projected at 7%, which is the highest among all major economics, India's economy has been hailed as a "bright star" by the international community in 75th year of its independence.



TAX INCENTIVES FOR CORPORATE SECTOR

In order to promote growth of manufacturing in cooperative sector, various measures have been taken to boost up the cooperative sector in India. The finance minister presented new tax advantages for cooperative entities and improvements in their technological infrastructure to support an inclusive economic model and encourage the bottom of the pyramid.

After the Government loosened restrictions to allow cooperatives to participate in India's growth story, the budget was announced a few weeks later. The Government allocated a total budget of Rs.1150.38 crore for the Ministry of cooperation for 2023-24, less than the revised estimate of Rs.1624.74 crore for 2022-23.



According to the finance minister, instead of existing rate of 30% surcharge, new cooperatives that start manufacturing operations before March 31, 2024 will be taxed at a flat 15% rate. The finance minister said, "This is expected to provide them with nearly Rs.10,000 crore in relief."

The budget suggests capping cash deposits and loan made by Primary Agricultural Cooperative Societies(PACS) and Primary Cooperative Agriculture and Rural Development Banks(PCARDBs) at Rs.2 lakh per members. In contrast to the current restriction of Rs.1 crore, cooperative societies now have a greater maximum of Rs.3 crore for TDS on cash withdrawals. The Government has already started computerizing 63000 PACS with Rs.2516 crore investment to create a national cooperative database and create a map of cooperative societies throughout the nation. Sample bylaws have been developed for cooperatives to become multifunctional PACS.

The ministry of cooperation issued cooperatives account for 25% of the production of soil nutrients, fifth of the fisheries industry, and a fifth of agricultural loans.



CONCLUSION:

A new national cooperation policy is being developed with the participation of the appropriate stakeholders like- experts, representatives from national, state, district and primary level cooperative societies, officials from the Union Ministry of Cooperation and the State Governments, in order to fully realize the potential of cooperatives. Government's promotion of an economic growth model centered on cooperatives, particularly for small and marginal farmers and other marginalized groups. There are 290 million members in 0.85 million cooperatives, most of whom are from marginalized and lower-income groups in rural areas, according to the Economic Survey2022-23

Women's Empowerment Takes Center Stage: Both Houses Passes Key Bill

"Yatra naryastu pu<mark>jyante rama</mark>nte tatra Devata, Yatraitaastu na pujyante sarvaastatrafalaah kriyaah."

Translation:

"Where women are honored, divinity blossoms, and where women are dishonored, all actions remain unfruitful"

While the bill had faced many challenges in the past 31 years, it was important for modern-day **BHARAT**.

We as a country have believed and prayed to the feminine goddesses Lakshmi, Saraswati, and Kali and yet there was discrimination and gender biases, in the world we still ranked 48th out of 146 in political empowerment of women and to bring a change The Constitution (One Hundred and Twenty-Eighth Amendment) Bill, 2023 has been unanimously passed by Lok Sabha and Rajya Sabha. The Bill seeks to reserve one-third of the total number of seats in Lok Sabha and state legislative assemblies for women.

On 20 September 2023, Lok Sabha passed the bill with 454 votes in favor and two against.

On 21 September 2023, The Rajya Sabha passed the bill unanimously with 214 votes in favor and none against.

What is the Background of the Reservation for Women in Politics in India?

In 1931, in their letter to the British Prime Minister, they submitted the official memorandum jointly issued on the status of women in the new Constitution by three women's bodies, leaders Begum Shah Nawaz and Sarojini Naidu.

The National Perspective Plan for Women recommended in 1988 that reservation be provided to women's rights from the level of the panchayat to that of Parliament

These recommendations paved the way for the historic enactment of the 73rd and



74th amendments to the Constitution which mandate all State governments to reserve one-third of the seats for women in Panchayati Raj Institutions and one-third of the offices of the chairperson at all levels of the Panchayati Raj Institutions, and in urban local bodies, respectively. Of these seats, one-third are reserved for Scheduled Caste/Scheduled Tribe women.

The National Policy for the Empowerment of Women (2001) stated that reservation will be considered in higher legislative bodies.

In May 2013, the Ministry of Women and Child Development constituted a committee on the status of women, which recommended ensuring at least 50% reservation of seats for women in all decision-making bodies of the government In 2015, the Report on the Status of Women in India noted that the representation of women in state assemblies and Parliament continues to be dismal.

Commencement of Reservation (New article - 334A):

The reservation will be effective after the census conducted after the commencement of this Bill has been published. Based on the census, delimitation will be undertaken to reserve seats for women.

The reservation will be provided for a period of 15 years. However, it shall continue till such date as determined by a law made by Parliament.

What are the Pros and Cons of the Bill?

With the passage of this bill the convention on the elimination of all forms of discrimination against women provides that discrimination against women must be eliminated in political and public life.

A more diverse legislature that includes a significant number of women can bring a broader range of perspectives to the decision-making process.

More Focus on gender based violence and its protection, women health issues and education and in general economic empowerement.

This bill has made us believe "Women are not only the architects of harmonious households but also the architects of progressive politics, for their influence spans from the hearth to the heart of governance, building a brighter future for all."

When it comes to CA Foundation- the entry gate of the Chartered Accountancy Course, is sheer becoming more difficult day by day due to some stringent changes. At the time, when there was CA-CPT exams, it used to be fully objective. Then, after 1st July, 2017, CA-CPT was replaced with CA Foundation and two papers became descriptive; and from here, this exam started becoming harder than previous. After this, ICAI decided to make it more difficult and then in order to this, they have come up with the New Scheme of Education and Training applicable from May 2024 exams and onwards where, there's stringent changes regarding to the subjects and passing requirements.

It is clearly visible that ICAI is making the entry level harder which leads to a less passing percentage in CA Foundation. In December 2022 and June 2023 exams, the passing percentage was 29.25% and 24.98% respectively, which indicates a declining rates of passing percentage.

According to them, CA Foundation is too easy to clear because they still have the perception of the old CA-CPT exams, which used to be easier than this. 



Tax Audit & Its Applicability u/s 44AB

What is Tax Audit??

The term Audit means Verification & inspection of accounts. There are various types of Audit under different laws. Tax Audit is defined as the inspection or verification of Book of accounts of the Assessee who is Carrying on any Business or a profession by an Auditor (i.e. Chartered accountant) to check or ensure whether the books of accounts prepared by assessee are as per the compliance of various provisions of income tax act 1961 or not. Auditor provide their Tax Audit report in Form 3CA (in case of company) or Form 3CB (In case of other than companies) & Form 3CD.

Who is Required to get their Account Audited u/s 44 AB??

∠ Let's discuss the applicability of Tax Audit u/s 44 AB of Income Tax Act,1961


- ✓ Tax Audit u/s 44 AB is applicable as follows:
- ➤ If a person is doing an business & his Total Sales, Turnover or Gross Receipts from such business during the previous year exceeds Rs.1 Crore.
- But in case of business where all cash transactions are up to 5% of Total Sales,
 Turnover or Gross Receipt then such threshold limit will increased to Rs.10
 Crore. (Amended in Finance Act,2021)
 (i.e. 95% of transaction in business are in online mode)
 - (i.e. 95% of transaction in business are in online mode)
- ➤ If a person carrying on an profession & Total Gross Receipts from such profession during the previous year exceeds Rs.50 Lakhs.
- ➤ If a person doing an business & opted for Presumptive Taxation Scheme u/s 44 AD in any of the last 5 previous year & declare the Profit or Gain lower than the Profit or Gain computed as per section 44 AD.
 - (i.e. lower than 6% or 8% of Turnover or Gross Receipts)



- ➤ If a person carrying on an profession & opted for Presumptive Taxation Scheme u/s 44 ADA & declare the Profit or Gain lower than the Profit or Gain computed as per section 44 ADA.
 - (i.e. lower than 50% of Gross Receipts)
- ➤ If a person engaged in plying, hiring or leasing of goods carriage & opted for Presumptive Taxation Scheme u/s 44 AE & claim Profit or Gain lower than the Profit or Gain computed as per section 44 AE.
- Fresumptive Taxation scheme u/s 44 BB & claim Profit or Gain lower than the Profit or Gain computed as per Section 44 BB.
- ➤ If foreign company engaged in civil construction & opted under Presumptive Taxation scheme u/s 44 BB & Claim Profit or Gain lower than the Profit or Gain computed as per section 44 BB.

All points are applicable individually not in aggregate!

If any person fall under any of the above category then they are required to get their account audited u/s 44 AB of Income Tax Act,1961.

TAX HAVENS

WHAT IS A TAX HAVEN?

A Tax Haven, or "offshore financial centre," is a country (or state) in which foreign investors pay taxes at an abnormally low rate, possibly even zero (rare).

By shifting their funds into or through tax havens, businesses and other investors can avoid paying taxes in high-tax countries.

MAJOR TAX HAVENS OF THE WORLD

> THE CAYMAN ISLANDS:

The Cayman Islands have a solid international reputation for providing a comprehensive range of financial services to a wide spectrum of clientele.

BERMUDA:

Bermuda has a 0% tax rate and no income tax whatsoever for investors and those looking off-shore. This makes it another perfect prospect for the world's wealth.

TAX LOSS

India loses approximately \$10.3 billion or Rs.70000 crore every year due to TAX HAVENS.

This amount could have been collected and used for economic as well as social development, but it can't be questioned since it is LEGAL.

There is approximately a tax loss of \$427 billion globally every year.

PERQUISITES OF TAX HEAVENS

- These TAX HAVENS provide either 0 or very low tax rates. Countries like MAURITIUS have 0 local taxes on income which makes it a creamy tax haven.
- > They have laws which provide you financial confidentiality.

WHY DID TAX HAVEN CONCEPT COME?

The **Double Taxation Avoidance Agreement** or DTAA is a tax treaty signed between India and another country (or any two/multiple countries) so that taxpayers can avoid paying **double taxes** on their income earned from the source country as well as the residence country.



CASE STUDY 01 - THE PANAMA PAPERS CASE

The Panama Papers scandal involved a leak of **11.5 million confidential documents from Panamanian law firm Mossack Fonseca**. German newspaper Süddeutsche Zeitung (SZ) reported the leak, which exposed more than 214,000 tax havens involving high-profile people, government officials, and entities from 200 different nations.

Some of the big names included Amitabh Bachchan, Aishwarya Rai Bachchan, Ajay Devgan and a lot more.

CASE STUDY 02 - VODAFONE VS COMMISSIONER OF INCOME TAX (CIT)

- Vodafone paid the said amount to Hutchison (HK) without deducting any TDS.
- ➤ By simply selling the Cayman Island shares (a co. having no value in itself without 67% interest in Indian co.) Hutchison has indirectly transferred shares of Hutchison Essar (Indian Co.) As a result of this indirect transfer Hutchinson had saved Capital gain tax in India.

PROGRESS OF THE CASE: HISTORICAL JUDGEMENT

SEPTEMBER 2007: Tax department issued notice to Vodafone (UK) for failure in withholding the tax on the payments made to Hutchinson (HK).

OCTOBER 2007: Vodafone (UK) filled a Writ petition in Bombay HC contending that the sale was between two Non Residents so non taxable in India.

SEPTEMBER 2010: Bombay HC–Transaction taxable in India, Vodafone filled petition to Supreme Court.

20TH JANUARY, 2012: Justice Kapadia :- "The government has no jurisdiction over Vodafone's purchase of mobile assets in India as the transaction took place in Cayman Islands between HTIL & Vodafone."

HOW DO TAX HAVEN COUNTRIES MANAGE DEVELOPMENT WITH EITHER NO / LESS TAXES ?

Tax Havens charge lesser amount of local taxes and direct taxes on Income but they charge a fairly good sum of indirect taxes, import-export duties etc. It also collects fees, charges, fines etc which forms a major source of revenue.



With so many giant companies entering their countries, development becomes a part and parcel of the process, and it is just a matter of years when growth and development start showcasing evidently.

Tax Havens are LEGAL and some giant companies like Apple, Nike & Flipkart have been legally using it for their Sueddeutsche tax benefits.
